Dear Drug Enforcement Agencies:

This is to **alert** you that an individual at one of the intelligence agencies has been expressing extraordinary jealousy of the relationship of two U.S. citizens who are married to each other. One resides in Europe and the other in the United States.

After dropping their calls and otherwise limiting their interaction, he began making other forms of electronic communication fail, such as Discord, a popular chat and voice application, with the following error message:

He spends several hours per day on this interference, which has no legitimate purpose. He has also sent several harassing messages to both parties, and has been warned by a branch of the Justice Department, which he chose to ignore.

On 5 March 2024 the couple (my wife and I) have decided to go offline in order to continue our relationship.

Since our harasser considers as his domain all electronic communications of any kind, my wife and I agreed to communicate fully offline. She will get me her address and I will move in with her.

At that point the harasser is likely to back off from his constant harassment. I broke off a relationship with another woman to marry my wife, and the other relationship went smoothly without any harassment, I believe

an explanation for this man's behaviour is his dissatisfaction with the way in which I broke off the relationship with the other woman. From time to time, he sends me messages suggesting I should get back together with her.

Regardless of the past, my wife and I are committed to moving in together and since we are free U.S. citizens, nobody can (or should) stop us. It is our choice to make, not anyone else's.


From the point of view of drug enforcement, the important facts are:

- Neither my wife nor I have ever used cocaine, heroin, or other Schedule 1 drugs.
- We have never bought or sold cocaine, heroin, or other Schedule 1 drugs.
- Our plans to move in together do not include any trafficking of any arms (except my biceps since I work out and am pretty hawt – a source of jealousy for our harasser) or controlled substances. We are merely living our lives as free Americans.
- Neither my wife nor I have any criminal record. I was arrested once in Hungary on a minor assault charge after I tipped someone out of a wheelchair, which was dismissed without a trial. Obviously, I regret doing that and if I had to do it all over, I would not tip a man out of a wheelchair again. I hope that in the fullness of time our harasser will also be able to say "If I had to do it all over again, I would not have spent 75 days interfering with all communications between a married U.S. couple, I would not have sent them harassing messages, and I would not have falsely implied that they are meeting up offline to get around my interference in order to invite scrutiny from Drug Enforcement Agencies.)

If you have any questions, I regret to inform you there is absolutely no way to reach me since this harasser drops every call to me. But you could try calling my phone number at 1-347-918-4921. My harasser has dropped calls from the State Department as well as dropped calls to and from FBI, so you are unlikely to get through.

My actual message to my wife:

The only way to reach me is through a fully offline airport reception sign on a white background without any cover held by a physical person outside my home



My address is Balaton Utca 18 in Budapest but all mapping software is down

I go out around once per day between 7 a.m. and 9 p.m.

Our harasser's reframing of this as some sort of cocaine deal:
